




#### **Background**




- Audiology and Ear, Nose and Throat (ENT) Outpatient Clinics for adults and children are held at both hospital sites (RSH and PRH). There are a number of community clinics held across Shropshire, Telford & Wrekin and Mid Wales.
- In our ENT and Audiology clinics we carried procedures that generate Aerosols (AGP), which present a risk of infections to patients and staff.
- Following an AGP the room and equipment require deep cleaning and the room then needs time to "rest" (for air circulation) before the next patient can be seen/treated. This cleaning process is extremely important to ensure we are COVID safe.
- Our Audiology clinic rooms need to be acoustically sound proofed, so they are unable to open windows to improve ventilation



#### **Background Continued**



- The cleaning process and "rest" time results in patients having to wait longer during appointments and in some circumstances may result in patients appointments being rescheduled.
- Infection Prevention and Control and national guidance recommend that improving air exchanges will reduce the "rest" time.
- Improving our estates to provide better air circulation within our clinics will:
  - reduce the risk of infections to patients and staff,
  - reduce the number of patients being delayed in clinic
  - reduce the number of cancellations.
- The service change is clinically led and improvements to the ventilation are urgently required to improve the clinical environment and support patient care.



Please see the graph above which shows the decrease in the number of outpatient procedures during 2020/21 compared to 2019/20 due to increased IPC measures.

## Proposed temporary service change



- SaTH has approved funding to install new air conditioning units (to improve air flow) in our ENT and Audiology clinic areas at RSH (Clinic 4).
- It will take 12-18 weeks to install the air conditioning units and, during this time, the ENT and audiology clinics will need to relocate to enable work to take place
- Whilst the work is carried out, clinic 4 can not be used and patients will temporarily receive their care at different locations.
- The ENT and audiology services will continue to be provided by SaTH



#### Where will patients receive their care?



- Whilst estate's work is carried out on clinic 4, ENT and audiology patients will receive their care at alternative locations
- For ENT patients, during this time patients will be seen in clinic at:
  - RSH within Clinic 7
  - Additional clinic capacity will be provided at PRH
  - Where appropriate telephone consultations will be provided
  - 436 patient a month will be affected



## **Audiology**



- For the duration of the improvement works the following arrangements have been put in place for audiology:
  - 3 clinic rooms in the Copthorne Building, RSH
  - increase in community locations (see following slide)
  - Clinics at PRH
- Approximately 1300 patients are seen per month at RSH.
   These patients will be seen at either RSH, PRH or a community location (closer to home)
- Approximately 8 Powys patients per month are seen at RSH.
   During the temporary service change these patients will be seen at RSH or Oswestry

#### Stakeholder Engagement

  - Children's Hearing Services Working Group
- Patients whose appointments have changed locations have been informed.
- Our Operational Team have also discussed the proposed service changes with the CCG, Powys Health Board

## **Equality Impact Assessment (EQIA)**



- A draft Equality Impact Assessment (EQIA) was completed by our Operational Team.
- A meeting to review the EQIA is planned for 28 April
- Once the EQIA has been reviewed by our patient and public members it will be submitted to the Public Assurance Forum for approval and our website will be updated



#### What's next?



- Clinic 4 has closed for estate's works to be completed. The work is expected to take 12-18 weeks, any changes to this timescale will be communicated, via our website.
