

- We are working through the design and planning to ensure our facilities will deliver the clinical model and core outcomes of the Future Fit consultation in the most effective and efficient way within the investment.

Background



- The hospital currently occupies approximately 21 hectares, with a variety of building types and scales from 2-storeys to 5-storeys.
- Several of the hospital buildings at the site are ageing.
- Failure to improve the configuration of the estate will only increase the risk of future disruption.

The Royal Shrewsbury Hospital proposals



The plans for RSH include approximately 30,000 sq. m of accommodation to provide:

- A new entrance, reception and hospitality offer as well as enhanced patient drop off facilities and accessible parking to cater across Shropshire, Telford and Wrekin, and mid-Wales
- A purpose designed large Emergency Medicine department with a paediatric zone aligned with a new urgent treatment centre
- An Acute Medicine floor
- Consultant-led Maternity, Gynaecology and Neonatal services with Midwifery led delivery
- A children's centre including enlarged children's assessment unit, ٠ children's inpatient, oncology and surgical services
- An adult Oncology and Haematology ward with increased single accommodation

The Royal Shrewsbury Hospital proposals



There will be two new front doors one to the Emergency Department • and one to the New Main entrance.

- There will be large new reception and triage areas, with dedicated ٠ waiting for adults and children.
- There will be an expanded provision for 10 ambulances, with a ۲ protective canopy.
- A new drop off and accessible parking directly outside the Emergency Department
- Relocated Helipad. ullet
- Emergency department purpose designed with a new larger resus area

Improving the hospital experience



- Areas of soft landscaping to soften the hospital's frontage and • enhance the patient and visitor experience.
- Double height atrium which will connect the new and the old hospital • with a lightweight structure.
- The café and waiting area will lead off from the atrium with pleasant • views into the new courtyard.

Transport



- Comprehensive review of the transport facilities onsite undertaken.
- Increase in overall parking.
- The staff car parking provision reorganised.
- Vehicle access points into the site will remain unchanged.
- Relocated hospital entrance, which will now face the major public car park.
- Increase in cycle parking.

We will continue to work with service users, local communities and colleagues as we develop our Travel and Transport plans for both hospitals.

- Aim to achieve BREEAM excellent, using sustainable building solutions such as solar panels.
- The project aims to be Net Zero Ready which means the building will be capable of adapting to future sustainable
- technologies.
- Proposals include neutral grassland, hedgerow mixed scrub
- and the introduction of shrub planting around the boundary of





Design – appearance and materials



- The building also sits back from the boundaries of the site, minimising the impact on neighbours.
- The existing hospital buildings are of a panellised concrete construction providing a clean, efficient, and effective new face for a modern hospital.
- The windows are glazed between floor and ceiling to maximise daylight within the hospital building.

Construction



- Some disruption to users and local residents in respect of noise, dust and vibrations.
- Residents will be consulted on a construction management plan, which will be agreed with the council.
- The development will be carried out in phases whilst maintaining the full operation of the hospital.

Feedback received so far from engagement



- Planning events were held on 19, 22, 24 July (all in person) and 1 August (online)
- The last colleague session was on 19 July when display boards were in SECC. These are now on display in Outpatients, both at RSH and PRH.
- To promote the events, the project team issued a community newsletter to 6,926 households, contacted local groups and key stakeholders including councillors and the local Members of Parliament.
- Comments and feedback received over the course of the three drop-in events and were largely supportive of the proposals, with some helpful comments on specific features.
- Some comments received welcoming the proposed changes to landscaping and proposed improvements to footpaths
- To date, we have received **53** feedback forms returned.







REAT PLACE O WORK

Feedback received so far from engagement



- Respondents identified the most important aspect as being reorganisation of the hospital's parking layout, including a new hospital entrance facing the major public carpark.
- Respondents identified the least important aspect as the improvements to the hospital experience with soft landscaping to the exterior, a new entrance leading to a café and modern courtyard spaces.
- The vast majority of respondents either like the design of the buildings or like the design of the buildings but have some reservations, a small number of respondents stated that they were unsure as to whether they liked the design of the buildings or not.
- There were a number of recurring themes, in both verbal and written feedback, during the Planning events, including: ٠
- The most common theme that was around parking.
- Many attendees and respondents stated that the existing buildings were dated and need upgrading.
- A number of people referenced the narrow entrance road and roundabout off Mytton Oak Road as a concern.
- Concerns about the increase noise, particularly from the helipad and ambulances as well as during construction.
- A few respondents raised the issue of a lack of public transport between the two hospital sites.

Engaging with community – next steps



- **DESIGN MEETINGS** ongoing1:50 Design meetings are being arranged with clinical teams and public representation on groups. We will contact PAF members who have also been part of focus groups to ask for nominations. There will also be one representative from PACE.
- CLINICAL FOCUS GROUPS- we are looking to hold the next clinical workstream focus groups as hybrid meetings – MS Teams and face to face. We intend to invite the scheme's design architects who will have details of the relevant floor plans for each group. We may need to hold meetings slightly later on the planned dates as we are working with the architects to confirm arrangements. We will be contacting all focus group attendees with details this week and also to ask any issues/areas they want including on the agenda. The outcomes of this will be reported through to the HTP programme through a paper including an action log
- TRAVEL & TRANSPORT FOCUS GROUP we are looking at 28 September as a possible date for this focus group (to be held on MS Teams).









We are entering an exciting phase for the programme as we design the detailed patient pathways. We are committed to engaging and working closely with our local communities, patients and colleagues to ensure we improve the experience for all the communities we serve.

- Medicine, emergency, surgery, anaesthetics and cancer focus group: 7 September and every three • months to follow
- Women's and children's focus group: **5 September** and every three months to follow ۲
- Clinical Support Services: **21 September** and every six months to follow •
- Travel and Transport focus group **possibly 28 September tbc** ۲
