




Where are we in the process?





- We've worked with our lead clinicians to add further detail into the clinical model to start to design the "flow" of clinical services (how our clinical teams will work and connect to each other).
- Seeking planning permission for building works at the Royal Shrewsbury Hospital
- Preparations underway to be ready for the implementation phase
- Public feedback is continuing to inform the development of our proposals. This involvement will continue and over the next few weeks, months and years there will be many opportunities for people to help us influence the physical environments and people's experience of our services.
















Location of the new build at RSH

Construction for RSH build





- Some disruption to users and local residents in respect of noise, dust and vibrations.
- Patients, staff and local residents will be consulted on a construction management plan, which will be agreed
 with the council.
- The development will be carried out in phases whilst maintaining the full operation of the hospital.






High level floor plans and artist's impressions – site location

Could we get information on circumstances when there have been more than two bereavement events at the same time and if that occurs frequently, consider having a double bereavement suite and one other room as additional flexibility? 16/11/2023	Wrekin ante-natal is at one end of PRH, the MLU at another end of the hosptal, scanning in a separate part and then the delivery suite in the W&C Centre. When the Consultant service moves to RSH it is possible there may be 4 different locations (scanning is not in the RSH new build) so appointment directions will need to be very clear.	Charlotte Robertshaw (Maternity Comms & Engagement) with HTP team	In the new build at RSH, the MLU will be alongside the Consultant Led Unit. The location of the antenatal services, currently in Mytton Oak House, are not yet determined. As part of our Estates strategy, we will review clinical adjustments at PRH.	IN PROGRESS
16/11/2023	It was noted that in the new RSH build the footprint could not accommodate maternity inpatients and the neonatal unit on the same floor without a loss of beds. This means that at RSH mums needing ongoing medical care will be downstairs on the post natal ward and they would need to go upstairs to see their baby in the neo-natal unit possibly in a wheel chair requiring extra help. Is there any option for the mother and baby to be on the same floor?	Tom Jones - HTP team and architects	There will be an increase of parenting rooms on the neonates floor (from 3 to 8). 



Info Slices

The Acute Medical Floor is a horseshoe shaped unit comprising AMA, AMU and Ward 22 Short Stay. We entered through AMU which was signposted from the Main Wards entrance. There was no signposting to AMA from this entrance. There was small text on the sign for the seated area saying 'Welcome to AMA seated area'.

Posters on the wall in this area tell people what to expect although the writing on these is quite small so they may not be easily read by all.

AMA has an open area with 12 comfortable, clean, reclining padded chairs in situ. At the time of our visit this area was quiet and we saw 3 of the chairs in use, however, if it were busy then privacy could be an issue. There is a nurse's station within this area where staff were completing paperwork.

When we first entered AMU it felt a busy and stressful environment. There were a lot of staff rushing around and it was noisy. About 30 minutes into our visit these activity levels had calmed down and it became much quieter.



Privacy

- Patients can be assessed and start their treatment in the chair area. On the day of our visit this area was very quiet, but we were told by Ward Managers and other staff that it can often be busy with patients waiting there over 24 hours sometimes due to lack of beds in the hospital.
- There could be an issue with privacy in the seating area when it is busy, and assessments need to be undertaken there .











Wayfinding / signage

- Further design development for high contrast easy to read signage
- Location map
- Differentiation between main hospital and emergency

Locality and materials

- Research and develop design ideas around the local landscape, the community and local materials that can be used as part of the design

Colour, shape & artwork

- Research and develop design ideas to mitigate sickness, nausea and dizziness
- Explore tonal variations
- Refine colour palette

Furniture

- Information boards that remove the clutter and confusion and have a decorative element to work alongside the artwork
- Explore how the seating can feel more private but remain wheelchair accessible
- Furniture for different user groups children through to elderly and identify their needs









Feedback - focus groups





Design for Paediatrics

- -Explore makaton for paediatric signage
- -Info slices to help with demystification in waiting areas
- -Work with local schools to identify aspects of design that will feel familiar to patients
- -Area to display artwork and information

Design for Neurodiversity

- -Spaces specifically for learning disabilities and autism for adults in the ED waiting area
- -Furniture that considers self injurious behaviour eg rounded corners and upholstered sides
- -Sensory map

Design for dementia

- Create a heat map of areas where older people will spend most time in the hospital and tailor design specifically for these areas
- Using the The Stirling standards for dementia-friendly design to inform the design development
- -Clear icons to support text on signage
- -Signage on wards/ bed bays that tells people where they are to support patients with delirium
- -Explore how to display clocks on wards
- -Places to sit and stop along corridors
